

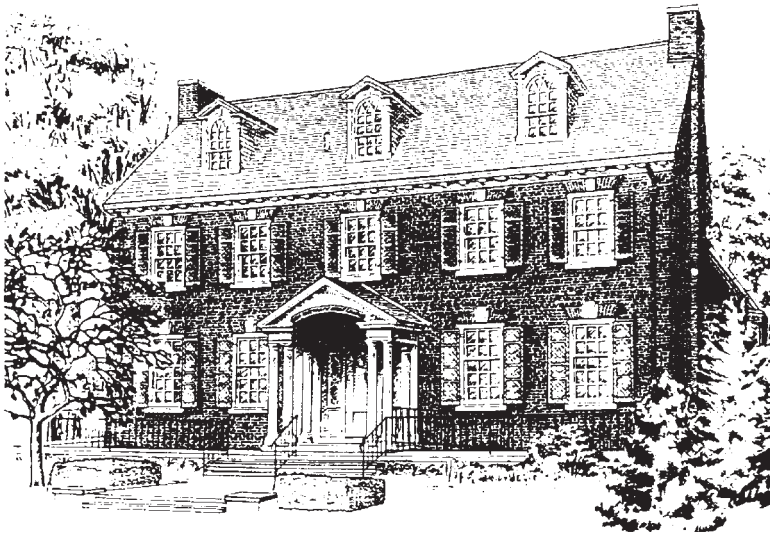

LUGO vs. PENNDOT

Appeal of License Suspension—Burden Shifting.

On August 29, 2022, Andres Rafa Garcia Lugo was convicted in Montgomery County of Careless Driving resulting in Unintentional Death, a summary violation. On September 7, 2022, PennDOT issued an Official Notice of Suspension to Andres Rafael Garcia Lugo, arguing that he was neither cited for nor convicted of that offense. Lugo appealed to the Court of Common Pleas, which granted a *de novo* hearing.

The Commonwealth cannot take away a person's liberty interests without due process. On appeal, a licensee may not attack the validity of the underlying conviction, but may challenge whether he was in fact convicted. A licensee need only rebut the Commonwealth's evidence by a preponderance. When an appellant successfully shifts the burden onto the Commonwealth, it must offer additional proof that the appellant was, in fact, the person convicted.

In its 1925(a) opinion, the Court reiterated that it found Lugo's testimony—that he was neither cited for nor convicted of the offense—credible, shifting the burden to the Commonwealth. The Commonwealth offered no additional evidence that the Lugo who appealed was the same person convicted. The Court rejected PennDOT's argument that Lugo was collaterally attacking the conviction itself, and found that Lugo had successfully rebutted the prima facie case against him.

COHEN, J., January 11, 2023. This Opinion is issued pursuant to Pa. R.A.P. 1925(a) in support of the Order entered on November 28, 2022, where I sustained Mr. Lugo's appeal of his driver's license suspension which arose from an alleged conviction for careless driving resulting in unintentional death.¹ The Commonwealth of Pennsylvania, Department of Transportation (“**PennDOT**”) asserts three errors in its Concise Statement of Errors, which I address as follows:

The Commonwealth cannot take away one's liberty without due process of law. U.S. Const. amend. XIV, §1; Pa. Const. Art. I,

§1. At the hearing, and after PennDOT offered the certified record into evidence, I found that Mr. Lugo credibly testified: (a) he was not cited for any traffic violation on May 29, 2022,² (b) he was neither convicted of nor pleaded guilty to any traffic violation on August 29, 2022, let alone for careless driving resulting in death, and (c) he never caused the death of anyone. Having shifted the burden,³ it was then incumbent upon PennDOT to offer additional evidence to prove the person in front of me was the person alleged to have been convicted. *Com., Dep't of Transp., Bureau of Traffic Safety v. Schaefer*, 304 A.2d 521 (1973). Because the Commonwealth had no additional evidence to offer, I granted Mr. Lugo's appeal.

In reaching my decision, I considered and rejected the Commonwealth's argument that Mr. Lugo, through his testimony, was attempting to impermissibly collaterally attack the conviction. It was not as if Mr. Lugo was stating "I was only going 15 miles per hour over the speed limit, not 20," or that "the person I hit was only slightly injured from the accident but ultimately died of other causes." Mr. Lugo testified it simply wasn't him and that he had no knowledge of the matters described in the records put into evidence by the Commonwealth. See *Orndoff v. Com., Dep't of Transp., Bureau of Driver Licensing*, 654 A.2d 1 (Pa. Cmwlth. 1994) (licensee may not attack validity of underlying conviction, but can challenge if in fact convicted and whether PennDOT acted lawfully).

Accordingly, having rejected the Commonwealth's argument that Mr. Lugo was collaterally attacking the conviction, based on Mr. Lugo's testimony, and absent any further evidence presented by PennDOT, I sustained Mr. Lugo's appeal and the suspension was rescinded.

²Upon questioning by PennDOT, although Mr. Lugo initially indicated he believed he was cited for speeding on May 29, 2022, he then produced the citation he was referencing, and it was for a September 22, 2021 speeding violation. He then clarified he was not cited other than on that single occasion in 2021. N.T. 12-14.

³In its Concise Statement of Errors, PennDOT contends Mr. Lugo failed to rebut the Commonwealth's *prima facie* case with "clear and convincing" evidence, citing *Kalina v. Com., Dep't of Transp., Bureau of Driver Licensing*, 929 A.2d 1233 (Pa. Cmwlth. 2007). In *Com., Dep't of Transp., Bureau of Traffic Safety v. Schaefer*, *infra*, the Commonwealth Court, relying on *Com v. Virnelson*, 243 A.2d 464 (Pa. Super. 1968), held that a licensee need only rebut the Commonwealth's evidence by a "preponderance of the evidence." *Schaefer*, 304 A.2d at 524. In this case, the distinction is one without a difference; Mr. Lugo's testimony satisfied both standards.
