



Summary Judgment—Causation—Expert Testimony.

In this trip and fall case, Defendants Lehigh Valley Health Hospital-Muhlenberg and Muhlenberg Realty Corporation moved for summary judgment arguing expert testimony was required to prove causation of injuries sustained by Plaintiff. Plaintiff argued no expert testimony was required because the injuries sustained were the immediate and direct and/or the natural and probable result of her fall.

The Pennsylvania Supreme Court has found that in cases where there is no obvious causal relationship between the conduct of a defendant and the harm suffered by a plaintiff, "unequivocal [m]edical testimony is necessary to establish the causal connection." *Polett v. Pub. Commc'ns, Inc.*, 126 A.3d 895, 930 (Pa. 2015) (quoting *Smith v. German*, 253 A.2d 107, 108 (Pa. 1969)). Conversely, "medical testimony is unnecessary in cases 'so readily apparent that a layman could diagnose (except by guessing) the causal connection.'" *Id. See, e.g., Lattanze v. Silverstrini*, 448 A.2d 605, 608–09 (Pa. Super. 1982).

The Court granted Defendants' motion for summary judgment. In doing so, the Court agreed with Defendants that expert testimony on the issue of causation was required. Therefore, because the Court found Plaintiff failed to produce evidence sufficient to create a genuine issue of material fact as to causation of Plaintiff'sinjuries, Plaintiff could not successfully pursue her claims and Defendants were entitled to summary judgment as a matter of law.

MEMORANDUM OPINION

REICHLEY, J., October 16, 2025. Defendants, Lehigh Valley Health Hospital-Muhlenberg and Muhlenberg Realty Corporation

(Collectively "Defendants") filed a motion for summary judgment. For the reasons set forth herein, Defendants' Motion is **GRANTED.**

FACTUAL AND PROCEDURAL HISTORY

On April 6, 2021, Sarah Montanez-Fontanez ("Plaintiff") attended a physical therapy appointment as a patient at the building situate at 1770 Bathgate Road, Bethlehem, Pennsylvania ("Facility") belonging to the Lehigh Valley Hospital-Muhlenberg campus. Montanez-Fontanez Dep., Feb. 21, 2024, 18-21. Plaintiff'sappointment was scheduled for 2:00 PM and she was accompanied to said appointment by her daughter. *Id.* at 21. Plaintiff's appointment was for the purpose of engaging in physical therapy for her right knee, which had been replaced approximately one month beforehand. Id. at 17:14-17. Plaintiff entered the facility with the assistance of a walker, which she had acquired following a left knee replacement approximately five years earlier. Id. at 26:5-13, 28:3-29:13. Plaintiff began physical therapy in her home before attending physical therapy at the Facility. Id. at 19:15-20:5. Plaintiff had attended physical therapy at the Facility approximately two other times. *Id.* at 20:20-21:3.

Following the conclusion of her appointment on April 6, 2021, Plaintiff and her daughter proceeded to exit the Facility. *Id.* at 21:17-21. As they were leaving, Plaintiff's daughter walked ahead of Plaintiff and pushed a button on a wall, causing the Facility's glass doors to open. Id. at 30. Plaintiff testified that as she proceeded through the door, the wheels of her walker got stuck on the rubber edge of a floormat. Id. at 30-33. Plaintiff fell onto her walker, causing it to break, hit her head on the edge of the door to the Facility, and hit her face on the ground. Id. at 30, 34:19-23. Plaintiff alleges to have suffered injuries to her head, right femur, and right shoulder was a result of the fall. Am. Compl. ¶16. When asked if any portion of the rubber of the floormat was turned up, Plaintiff testified that it was and indicated part of the rubber was "kind of worn out." *Id.* at 33:23-34:8. Plaintiff testified that she did not have any problems getting over the floormat when heading in to her appointment and that she always used the same doorway when entering and exiting the building. *Id.* at 21:13-16, 24:23-25:1. Plaintiff was helped up, given an ice pack for her eye, and was subsequently transported by ambulance to St. Luke's Hospital. *Id.* at 35-36.

Plaintiff filed her Complaint on March 27, 2023 and filed an Amended Complaint on June 22, 2023. Defendants filed their Answer on July 19, 2023. Discovery was conducted by the parties and Defendants Lehigh Valley Health Network, Lehigh Valley Health Network, Inc., Lehigh Valley Hospital-Muhlenberg, and Muhlenberg Realty Corporation filed a Motion for Summary Judgment on October 1, 2024. Plaintiff filed her Reply in Opposition thereto on October 15, 2024. The Court heard oral argument on October 16, 2024, after which time the matter was taken under advisement. On December 17, 2024, the Court denied the Motion for Summary Judgment.

On January 16, 2025, a stipulation was reached by the parties to dismiss Lehigh Valley Health Network, Lehigh Valley Health Network, Inc., John/Jane Does 1-10, and ABC Corp. 1-10 from the case with prejudice and Plaintiff agreed to not seek liability under a corporate negligence theory at trial. On February 19, 2025, upon Praecipe filed by the Plaintiff, the case was remanded to arbitration. On April 10, 2025, an arbitration award was entered in favor of Defendants and against the Plaintiff. Plaintiff filed a Notice of Appeal from the award on May 2, 2025. On June 3, 2025, a case management Order was entered, establishing new pre-trial conference and jury trial dates for the case.

On July 18, 2025, an Order was entered disposing of Motions in Limine filed by the Defendants. In pertinent part, the Order partially granted and partially denied Defendants' Motion in Limine to preclude expert testimony from being presented by Plaintiff's treating providers. Absent production of an expert report, Plaintiff's treatment physicians would be permitted to present testimony at trial limited to the opinions formed at the time the treating physicians rendered medical care and treatment to Plaintiff, but would be precluded from offering testimony related to causation of Plaintiff's alleged injuries. After Plaintiff did not seek reconsideration of the July 18, 2025 Order and did not move to supplement her pre-trial statement with any expert reports, Defendants filed the instant Motion for Summary Judgment on August 26, 2025. Plaintiff filed Response in Opposition thereto on September 26, 2025, Defendants filed a Sur Reply on October 6, 2025.

Argument on the Motion was held on October 7, 2025, after which time the matter was taken under advisement. Defendants filed a Supplemental Sur Reply on October 8, 2025.

This Opinion follows.

DISCUSSION

The standard of review for a motion seeking summary judgment is as follows:

Pennsylvania law provides that summary judgment may be granted only in those cases in which the record clearly shows that no genuine issues of material fact exist and that the moving party is entitled to judgment as a matter of law. The moving party has the burden of proving that no genuine issues of material fact exist. In determining whether to grant summary judgment, the trial court must view the record in the light most favorable to the non-moving party and must resolve all doubts as to the existence of a genuine issue of material fact against the moving party. Thus, summary judgment is proper only when uncontroverted allegations in the pleadings, depositions, answers to interrogatories, admissions of record, and submitted affidavits demonstrate that no genuine issue of material fact exists, and that the moving party is entitled to judgment as a matter of law. In sum, only when the facts are so clear that reasonable minds cannot differ, may a trial court properly enter summary judgment.

 $Milshteyn\ v.\ Fitness\ Int'l.,\ LLC,\ 271\ A.3d\ 498,\ 502–03\ (Pa.\ Super.\ 2022)\ (quoting\ Weible\ v.\ Allied\ Signal,\ Inc.,\ 963\ A.2d\ 521,\ 525\ (Pa.\ Super.\ 2008)).$

A material fact is one that directly affects the outcome of the case. *Kuney v. Benjamin Franklin Clinic.*, 751 A.2d 662, 664 (Pa. Super. 2000). For purposes of rebutting a motion for summary judgment, a nonmoving party may not rely merely upon allegations in pleadings, but must set forth specific facts by way of affidavit or in some other way to demonstrate that a genuine issue of material fact exists. *Banks v. Trustees of University of Pennsylvania*, 666 A.2d 329 (Pa. Super. 1995); *see also*, Pa.R.C.P. 1035.3(a).

Defendants argue they are entitled to summary judgment because Plaintiff cannot offer testimony related to causation of Plaintiff's alleged injuries at the time of trial. Causation is a required element of Plaintiff's negligence action. "A cause of action in negligence requires a showing of four elements: (1) the defendant had a duty to conform to a certain standard of conduct; (2) the defendant breached that duty; (3) such breach caused the injury in question; and (4) the plaintiff incurred actual loss or damage." Pyeritz v. Com., 32 A.3d 687, 692 (Pa. 2011) (citing Krentz v. Consolidated Rail Corp., 910 A.2d 20, 27 (Pa. 2006)).

As noted above, the Court entered an Order on July 18, 2025 disposing of Motions *in Limine* filed by the Defendants. In pertinent part, the Order partially granted and partially denied Defendants' Motion *in Limine* to preclude expert testimony from being presented by Plaintiff's treating providers. Absent production of an expert report, Plaintiff'streatment physicians would be permitted to present testimony at trial limited to the opinions formed at the time the treating physicians rendered medical care and treatment to Plaintiff, but would be precluded from offering testimony related to causation of Plaintiff's alleged injuries. Since the entry of the July 18, 2025 Order, Plaintiff has not supplemented the record with an expert report on causation.

When Plaintiff was asked what part of her body hit the ground after her fall, she replied, "[w]ell, I fell on my face, so it was my head, my eye, my shoulder, and my knee, all on the right side." Montanez-Fontanez Dep., Feb. 21, 2024, 18-21. Plaintiff asserts as a result of her fall, "[s]he suffered, among other injuries, an intracranial bleed, chip fracture of her peripatellar, and injuries to her right knee …" Pl.'s Mem. of Law in Supp. of Resp. to Mot. for Summ. J., p. 7. Defendants argue that because Plaintiff cannot offer expert medical opinion from any source at the time of trial to show causation of her injuries, Plaintiff will be unable to meet her burden of proof. Plaintiff argues that no expert testimony is required in this case because her injuries sustained were the immediate and direct and/or the natural and probable result of her fall.

The Pennsylvania Supreme Court has found that in cases where there is no obvious causal relationship between the conduct

of a defendant and the harm suffered by a plaintiff, "unequivocal [m]edical testimony is necessary to establish the causal connection." Polett v. Pub. Comme'ns, Inc., 126 A.3d 895, 930 (Pa. 2015) (quoting Smith v. German, 253 A.2d 107, 108 (Pa. 1969)). Conversely, "medical testimony is unnecessary in cases 'so readily apparent that a layman could diagnose (except by guessing) the causal connection.'" Id. See, e.g., Lattanze v. Silverstrini, 448 A.2d 605, 608–09 (Pa. Super. 1982). In the *Lattanze* case, the Pennsylvania Superior Court reviewed cases having an obvious causal relationship and cases in which an obvious causal relationship did not exist. Cases having an obvious causal relationship were found by the Superior Court to have two common characteristics: "The first is that the respective plaintiffs began exhibiting symptoms of their injuries immediately after the accident or within a relatively short time thereafter. The second is that the injury complained of was the type one would reasonably expect to result from the accident in question." *Id.* at 608.

In other words, "[a]n obvious causal relationship exists where the injuries are either an 'immediate and direct' or the 'natural and probable' result of the alleged negligent act." *Grossman v. Barke*, 868 A.2d 561, 567 (Pa. Super. 2005) (quoting *Matthews v. Clarion Hosp.*, 742 A.2d 1111 (Pa. Super. 1999). For examples of cases in which it was determined that the injuries complained of were either an "immediate and direct" or the "natural and probable" result of the alleged negligent act and, therefore, expert medical testimony was not needed to prove causation, *see*, *e.g. Simmons v. Mullen*, 331 A.2d 892 (Pa. Super. 1974) (minimal organic brain damage caused by being struck on the head by a car and knocked unconscious); *Fenstermaker v. Bodamer*, 171 A.2d 641 (Pa. Super. 1961) (neck, shoulder and elbow pain developed shortly after an auto accident, doctor prescribed a neck brace and leather collar to ease the pain).

Plaintiff argues that hospital records documented by her treating physicians show the immediate and direct connection between her fall on April 6, 2021 and her injuries. For example, St. Luke's Hospital Records dated April 6, 2021 indicate in pertinent part that Plaintiff was evaluated by the hospital's trauma service after her fall and indicate that Plaintiff was "found to have bilateral frontoparietal subarachnoid hemorrhages and possible

nondisplaced lateral condyle periprosthetic femur fracture." Pl.'s Mem. of Law in Supp. of Resp. to Mot. for Summ. J., Exhibit D, p. 163. Orthopedic records dated April 13, 2021 report that Plaintiff had intracranial bleed at the time of her fall, was told she had a possible peripatellar fracture, and that x-rays performed on April 13, 2021 show possible small chip fracture off the patella. Pl.'s Mem. of Law in Supp. of Resp. to Mot. for Summ. J., Exhibit E, p. 127, 129.

After Plaintiff's fall, she was transported to a hospital and medical records compiled on the same day she fell and over the following days indicate Plaintiff was diagnosed with the types of injuries a layperson could expect to flow from such a fall (i.e. injuries to Plaintiff's knee, head, and shoulder). However, Defendants assert that cases which do not require expert testimony to prove causation of injuries are distinguishable from this matter because, unlike the plaintiffs in those cases, Plaintiff was not in good health and has had issues with her right knee and shoulder before the fall occurred. Defendants argue Plaintiff's right knee replacement performed one month prior to the fall, her attendance of physical therapy for her right knee, and other medical circumstances of Plaintiff could have caused or contributed to her injuries such that expert testimony on causation is required. Defendants point out that Plaintiff complained of bilateral knee pain as early as 2012, she had osteoarthritis in her right knee which was labeled as "severe" and/or "advanced.," and she had documented bilateral shoulder pain as early as 2014. Defs.' Supp. Sur Reply, Exhibit A at #00607, #00663, #01012, #00746, #03798. Defendants also argue Plaintiff's medical history contains chemotherapy and radiation treatments which could impact the health of her body and that she had been diagnosed with chronic hypertension while taking aspirin medication which can cause intracranial bleeding. Id. at #2178-2181, #00838, #00625, #02028.

Defendants posit that cases within which plaintiffs were not required to present expert testimony to establish causation involved plaintiffs which were not exhibiting physical symptoms complained of or other adverse conditions of poor health prior to the alleged injuries. See, e.g., Lattanze, 448 A.2d at 607 ("Prior to the accident,

appellant did not have any of the physical problems that he exhibited following it"); see also, Tabuteau v. London Guarantee & Acc. Co., Ltd., 40 A.2d 396, 398 (Pa. 1945) ("Plaintiff had been in excellent health, and had done the same work for thirty years before the accident. But immediately after the accident he was disabled by a perfectly obvious injury which a layman could diagnose, and he was unable to work as before"); see also, Fenstermaker v. Bodamer, 171 A.2d 641, 642–43 (Pa. Super. 1961) ("Plaintiff testified that his health was good prior to the accident and that he never had any trouble with his neck before the accident"); see also, Munns v. Easthome Furniture Indus., Inc., 164 A.2d 30, 32 (Pa. Super. 1960) ("It must be remembered that the claimant never had any sensations of this character prior to the accident"); see also, Matthews v. Clarion Hosp., 742 A.2d 1111, 1115–16 (Pa. Super. 1999) ("Nurse Schubert's report further indicates that when patient was admitted to the hospital, all of her extremities were found to be in normal condition.").

By contrast, Defendants cite to a recent unpublished Superior Court case, *Norman v. Greene*, 2025 WL 2555819 (Pa. Super. 2025), which found that expert testimony was required where the plaintiff therein had allegedly sustained a broken wrist from a car accident and the wrist had been broken on a previous occasion.

In response, Norman disagrees with the court's conclusion, insisting that "it would stand to be reasonable to conclude that since [his] wrist was broken in a car accident, a second car accident could cause further injury to the same wrist." Appellant's Brief, at 13. We are not persuaded. The principle cited by Norman is described as "an exception" to the general rule that expert testimony is needed and applies only "where the injuries are either an 'immediate and direct' or [] 'natural and probable' result of the alleged negligent act." Lattanze, 448 A.2d at 608 (citation omitted). In Lattanze, we held that injuries sustained in a car crash did not require expert testimony because the "symptoms manifested themselves the same day" and the plaintiff did not "suffer[] from any of the physical symptoms prior to the accident in question." Id. at 609. As the trial court noted, Norman

claimed that he immediately began exhibiting symptoms, but he did not visit any medical provider to corroborate this assertion. Furthermore, he had a preexisting injury.

Norman, 2025 WL 2555819, at *4 (emphasis added).

The *Norman* case though is distinguishable from the matter before the Court only to the extent the plaintiff in *Norman* did not visit any medical provider to corroborate the injury to his wrist resulting from the accident. Otherwise, the two cases are similar. The plaintiff in *Norman* and Plaintiff herein both allegedly sustained injuries to bodily parts which had prior medical histories. The parties have not cited any cases which directly answer the question of whether plaintiffs who experience physical symptoms or conditions incurred before the event in question must present expert testimony as to the causation of their injuries.

However, as cited above in *Polett v. Pub. Commc'ns, Inc.*, expert medical testimony is only needed where there is not an obvious causal relationship between Plaintiff's injuries and Defendant's conduct. Accordingly, the Court agrees with Defendants that an expert witness offering causation testimony is needed. Unlike the plaintiffs in the *Lattanze*, *Tabuteau*, *Fenstermaker*, Munns, and Matthews cases, the Plaintiff in the current case had problems with her knee and shoulder before the accident. The facts surrounding Plaintiff's injuries are not so apparent that a layperson could diagnose the cause of Plaintiff's injuries as being solely from the alleged fall, or from her diagnosed osteoarthritis, her past chemotherapy and radiation treatments, her knee replacement, her aspirin intake with chronic hypertension, or from any combination of these potential causes. For the foregoing reasons, the Court agrees with Defendants that expert testimony on the issue of causation is required in the particular circumstances of this case.

CONCLUSION

As noted above, Plaintiff did not produce an expert report on the issue of causation, did not supplement the record when given the opportunity to do so, and has not produced any expert testimony." Consequently, the Court finds Plaintiff has failed to produce evidence sufficient to create a genuine issue of material fact as to causation of Plaintiff's injuries. As a result, Plaintiff cannot successfully pursue her claims and Defendants are entitled to summary judgment as a matter of law. Defendants' Motion for Summary Judgment is **GRANTED**.

ORDER
