



#### COMMONWEALTH v. ANONIA

#### Search and Seizure—Motion to Suppress

Defendant, Francis Anonia, was charged with Interception, Disclosure or Use of Wire, Electronic or Oral Communications, Criminal Use of Communication Facility, and Invasion of Privacy. Counsel for the defendant filed "Defendant's Motion to Suppress and Exclude Physical Evidence", wherein it was alleged that the discovery of "unlawful videos" on the defendant's cell phone was the result of the detective using "false pretenses" to secure the defendant's "abandonment" of his phone, and in essence, that the defendant was misinformed about relinquishing possession of his cell phone.

To prevail on a suppression motion, a defendant must demonstrate a legitimate expectation of privacy in the items seized, and such expectation cannot be established where a defendant has meaningfully abdicated his control, ownership or possessory interest.

A request to search a cell phone must provide a link between the cell phone and the crimes listed in the warrant. Indeed, even when there is probable cause to suspect the defendant of a crime, police may not search his or her cell phone to look for evidence unless they have information establishing the existence of particularized evidence likely to be found there.

The Court denied Defendant's Motion to Suppress. The Court found, *inter alia*, that the defendant's actions suggest he abandoned any expectation of privacy in the cell phone, and the dispute over whether the cell phone was abandoned was a distraction because the cell phone was not searched until a search warrant was secured and executed for its contents. The detective's conversation with the defendant and his muddled explanation of the "Abandonment" form had no impact on the constitutionality of the subsequent search. The Court also found that based upon the totality of the circumstances, there was a substantial basis for concluding that there was a fair probability that the defendant's cell phone contained evidence of crimes.

#### OPINION

Steinberg, *J.*, November 21, 2025. The defendant, Francis Anonia, has been charged with Interception, Disclosure or Use of Wire, Electronic or Oral Communications<sup>1</sup> (5 counts), Criminal

Use of Communication Facility<sup>2</sup> (5 counts), and Invasion of Privacy<sup>3</sup> (9 counts). The defendant is alleged to have surreptitiously placed a cell phone in a dressing room at Parkland High School for the purpose of recording images of a student in a state of undress.

The allegations came to light following the execution of a search warrant by the Allentown Police Department at the defendant's address, 525 North Berks Street in Allentown. The results of the search warrant led to child pornography charges against William Marshall,<sup>4</sup> who was identified in a subsequent search warrant as the defendant's "fiancé." Several digital devices were seized during the execution of the original search warrant, including an Apple iPhone with a unicorn case which was identified as the defendant's. The aforementioned Apple iPhone remained in the custody of the Allentown Police Department until this investigation of the defendant.

An investigation involving the defendant began in earnest with a ChildLine referral which alleged that the defendant was having inappropriate contact with a male student of the Parkland School District. The reported behavior involved "sexually suggestive" innuendos while the student was in a changing area for a student musical. The student alleged that the defendant made those suggestive remarks while he was in his underwear waiting to change into his costume. Both the student and teacher who made the report were interviewed.

Other students with similar allegations were identified by Detective Gregg Dietz, the affiant in this case. One of those former students described receiving special attention from the defendant, which included the purchase of "airfare, hotels, and excursions for a trip to Costa Rica." During that trip, the defendant plied the student with beer and made unwanted advances towards him,

including attempting to kiss him and grab his genitals. Unfortunately, the student's recollection of the events was limited, but after he returned from the trip with the defendant, he went to see a doctor due to "rectal pain and discomfort." While in Costa Rica, the defendant took numerous photos of that trip with his cell phone.

Detective Dietz, through his investigation of the aforementioned complaints of inappropriate contact by the defendant, learned the defendant maintained the "same telephone number" as the cell phone in the possession of the Allentown Police Department. All of the information acquired as part of his investigation led Detective Dietz to request a search warrant for the defendant's cell phone. On June 6, 2024, Judge Anthony granted the request, and the cell phone was searched on June 7, 2024.

#### MOTION TO SUPPRESS

On August 8, 2025, counsel for the defendant filed "Defendant's Motion to Suppress and Exclude Physical Evidence." It is alleged, according to counsel's motions, that the discovery of "unlawful videos" on the defendant's cell phone was the result of Detective Dietz using "false pretenses" to secure the defendant's "abandonment" of his phone. Counsel, while using harsher allegations in his motion, in reality, alleges that the defendant was misinformed about relinquishing possession of his cell phone. He was told he had two choices: allow law enforcement (1) to search and destroy the cell phone; or (2) search and return it to the defendant. The defendant requested the first option and signed a variation of a "Consent to Search Cellular Telephone..." form, which was now titled "Abandon i-Phone w/Unicorn Case." The remaining paragraphs contained the standard consent language permitting law enforcement to search the defendant's cell phone.

A hearing on the Motion to Suppress was held on October 13, 2025, during which Detective Dietz testified. Additionally, the original search warrant executed at the defendant's address, the receipt/inventory documenting the items seized during the execu-

tion of that warrant,<sup>7</sup> the "Abandon i-Phone w/Unicorn Case" form,<sup>8</sup> a segment of an interview with the defendant,<sup>9</sup> and the search warrant for the defendant's cell phone<sup>10</sup> were introduced into evidence.

The testimony and documentation revealed that the defendant's cell phone remained in the custody of the Allentown Police Department from February 23, 2023, the date of the original search warrant, until May 14, 2024, when it was transferred to Detective Dietz. While the cell phone was transferred to Detective Dietz, it was not searched until June 7, 2024. It was searched only after Detective Dietz secured a search warrant. The "Abandonment" form, while acknowledging the defendant's relinquishment of the cell phone, was not used to search the cell phone.

#### DISCUSSION

#### A. Relinquishment of Cell Phone

The defendant alleges Detective Dietz used skullduggery to coerce him to surrender his cell phone. The defendant, who had expressed no interest in the cell phone's return, signed the "Abandonment" form with the expectation that the cell phone would be destroyed. The cell phone may have been destroyed as the defendant requested, but an investigation into the defendant uncovered new allegations which led to Detective Dietz securing a search warrant for that cell phone.

The initial seizure of the cell phone was not contested, and the defendant never filed a Motion for Return of Property. He never showed any interest in the cell phone after its seizure. It was only after Detective Dietz secured his cell phone that a discussion regarding its disposal was initiated. His actions suggest he abandoned any expectation of privacy. As explained in *Commonwealth v. Hutchinson*, 343 A.3d 199, at \*5 (Pa.Super. June 6, 2025)(per-

suasive authority), quoting Commonwealth v. Byrd, 987 A.2d 786, 790 (Pa.Super. 2009), "it is axiomatic that a defendant has no standing to contest the search and seizure of items which he has voluntarily abandoned." In other words, "[t]o prevail on a suppression motion, a defendant must demonstrate a legitimate expectation of privacy in the ... [items] seized, and such expectation cannot be established where a defendant has meaningfully abdicated his control, ownership or possessory interest." *Id.* As further explained in *Hutchinson*, relying upon both *Byrd* and *Commonwealth v. Shoatz*, 366 A.2d 1216 (Pa. 1976):

Abandonment is primarily a question of intent, and intent may be inferred from words spoken, acts done, and other objective facts. All relevant circumstances existing at the time of the alleged abandonment should be considered. The issue is not abandonment in the strict property-right sense, but whether the person prejudiced by the search had voluntarily discarded, left behind, or otherwise relinquished his interest in the property in question so that he could no longer retain a reasonable expectation of privacy with regard to it at the time of the search.

In other words, abandonment can be established where an individual's surrender of possession of the property constitutes such a relinquishment of interest in the property that a reasonable expectation of privacy may no longer be asserted.

Here, the defendant's interest was in the disposal of his cell phone, not maintaining any legitimate expectation of privacy. As Sensibaugh observed, "the societal interest in protecting a child or preserving direct digital evidence of ... abuse of that child that could easily be destroyed outweighs any legitimate expectation of privacy ... . [I]n light of the totality of the circumstances and a proper balancing of societal interests, [the defendant] no longer had a legitimate or reasonable expectation of privacy in the phone." Id. at \*6.13

The dispute over whether the cell phone was abandoned is actually a distraction because the cell phone was not searched until a search warrant was secured and executed for its contents. Detective Dietz's conversation with the defendant and his muddled explanation of the "Abandonment" form had no impact on the constitutionality of the subsequent search.

#### B. Probable Cause for Search Warrant

The defendant contends that the search warrant for the defendant's cell phone failed to provide probable cause for its issuance. <sup>14</sup> The challenge is to the four corners of the warrant, requiring that information amounting to probable cause to support the search be recited within the warrant itself. *Commonwealth v. Harris*, 317 A.3d 603, at \*7 (Pa.Super. March 20, 2024)(persuasive authority). "Probable cause is determined by the totality of the circumstances. In determining whether probable cause exists to support a search warrant, the issuing authority is simply to make a practical, common-sense decision whether, given all the circumstances set forth in the affidavit ... there is a fair probability that

evidence of a crime will be found in a particular place." *Commonwealth v. Green*, 265 A.3d 541, 551 (Pa. 2021)(internal citation and quotation omitted)(probable cause to search all digital devices established). In *Commonwealth v. Quarto*, 2025 WL 2926467 (Pa. Super. October 15, 2025)(persuasive authority), it was similarly explained in the context of a search of a cell phone:

Probable cause exists where the facts and circumstances within the affiant's knowledge and of which he has reasonably trustworthy information are sufficient in themselves to warrant a man of reasonable caution in the belief that a search should be conducted. In issuing a search warrant, the task of the issuing magistrate is simply to make a practical, commonsense decision whether, given all the circumstances set forth in the affidavit before him, including the veracity and basis of knowledge of persons supplying hearsay information, there is a fair probability that contraband or evidence of a crime will be found in a particular place. In determining whether the warrant is supported by probable cause, the magistrate may not consider any evidence outside the four-corners of the affidavit.

The duty of a reviewing court is simply to ensure that the magistrate had a substantial basis for concluding that probable cause existed. In so doing, the reviewing court must accord deference to the issuing authority's probable cause determination, and must view the information offered to establish probable cause in a common-sense, non-technical manner. When considering whether probable cause exists, we consider the totality of the circumstances.

A request to search a cell phone must provide a link between the cell phone and the crimes listed in the warrant. See Commonwealth v. Johnson, 240 A.3d 575, 587 (Pa. 2020) (plurality)(holding that 'where law enforcement seeks to search a person's cell phone based on the person's mere proximity to illegal contraband, some link sufficient to connect the two must be provided in the affidavit of probable cause'). Indeed, even when there is probable cause to suspect the defendant of a crime, police may not search his or her cell

phone to look for evidence unless they have information establishing the existence of particularized evidence likely to be found there. *See Id.* at 587-88.

*Id.* at \*4 (some citations omitted).

Here, the cell phone was seized as part of the child pornography investigation into the defendant's significant other, with whom he resided. Those allegations by themselves would have raised suspicion, but did not establish a sufficient nexus to establish probable cause to search the cell phone. However, the investigation into the defendant evolved with the ChildLine referrals and the subsequent allegations of inappropriate contact between the defendant and underage students. The defendant, who was both a teacher and Administrative Director of Visual and Performing Arts at Parkland High School, had access to the students by virtue of his position of authority. Information in the affidavit also corroborated his use of his cell phone to create a diary of his activities.

Detective Dietz was unsure what crimes would be exposed with the issuance of the search warrant, but that does not affect its issuance. As previously explained:

The existence of probable cause is measured by examining the totality of the circumstances. Probable cause exists where the facts and circumstances within the affiant's knowledge and of which he or she has reasonably trustworthy information are sufficient in and of themselves to warrant a person of reasonable caution in the belief that a search should be conducted. [The issuing authority], when deciding whether to issue a search warrant, must make a practical, commonsense decision whether, given all of the circumstances set forth in the affidavit ... including the veracity and basis of knowledge of persons supplying hearsay information, there is a *fair probability* that contraband or evidence of a crime will be found in a particular place. Conversely, a court reviewing a search warrant determines only if a substantial basis existed for the magistrate to find probable cause.

Commonwealth v. Choice, 2025 WL 2672703, at \*11 (Pa.Super. September 11, 2025)(persuasive authority)(emphasis in original),

quoting Commonwealth v. Kimmel, 331 A.3d 26, 30 (Pa.Super. 2025). See also Commonwealth v. Kane, 210 A.3d 324, 333 (Pa. Super. 2019).

Based upon the totality of the circumstances, including the images found on other devices found within the defendant's household as part of a child pornography investigation, and Detective Dietz's discovery of the defendant's improper contact with students under his supervision, there was a substantial basis for concluding that there was a fair probability that the defendant's cell phone contained evidence of crimes.

For all the foregoing reasons, the "Defendant's Motion to Suppress and Exclude Physical Evidence" is denied.

#### **ORDER**

**AND NOW,** this 21st day of November, 2025, upon consideration of the "Defendant's Motion to Suppress and Exclude Physical Evidence" (hereinafter Motion to Suppress), and after hearing held on October 13, 2025, and examination of exhibits introduced at said hearing, and review of the memoranda of counsel;

IT IS HEREBY ORDERED that the defendant's Motion to Suppress is **DENIED**.
